SWITZERLAND AMONG THE GLOBAL ELITES FOR RESEARCH ACTIVITIES

In 2021, Switzerland spent a total of 24.6 billion Swiss francs on research and development (R&D) activities, further details of which can be found in a [press release](#) issued by the Federal Statistical Office (FSO). In comparison with the last survey in 2019, experts from the FSO have observed investment growth of +4 percent in this area.

Measured against Gross Domestic Product (GDP), spending on R&D in 2021 amounted to 3.4 percent. With this level of R&D intensity, Switzerland ranks fourth in a global comparison behind Israel (5.6 percent), South Korea (4.9 percent) and the USA (3.5 percent). This new peak value for R&D intensity also underlines “the importance of R&D activities for Switzerland”, as the FSO writes in the press release.

Universities and private companies together account for 96 percent of research activities overall. In terms of funds spent, the private sector takes top spot at 16.8 billion. In 2021, universities spent around 6.9 billion Swiss francs on R&D activities. The Swiss federal government and the cantons contributed 6.6 billion Swiss francs, which mainly went to the universities.

Nearly 140,000 people were involved in the research undertakings during the reporting year. The majority of researchers are employed by universities, while slightly more than one third of research jobs were occupied by women in 2021. However, this share has hardly changed since the last survey in 2019.

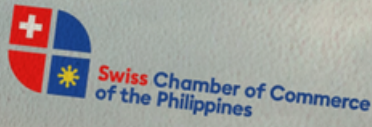

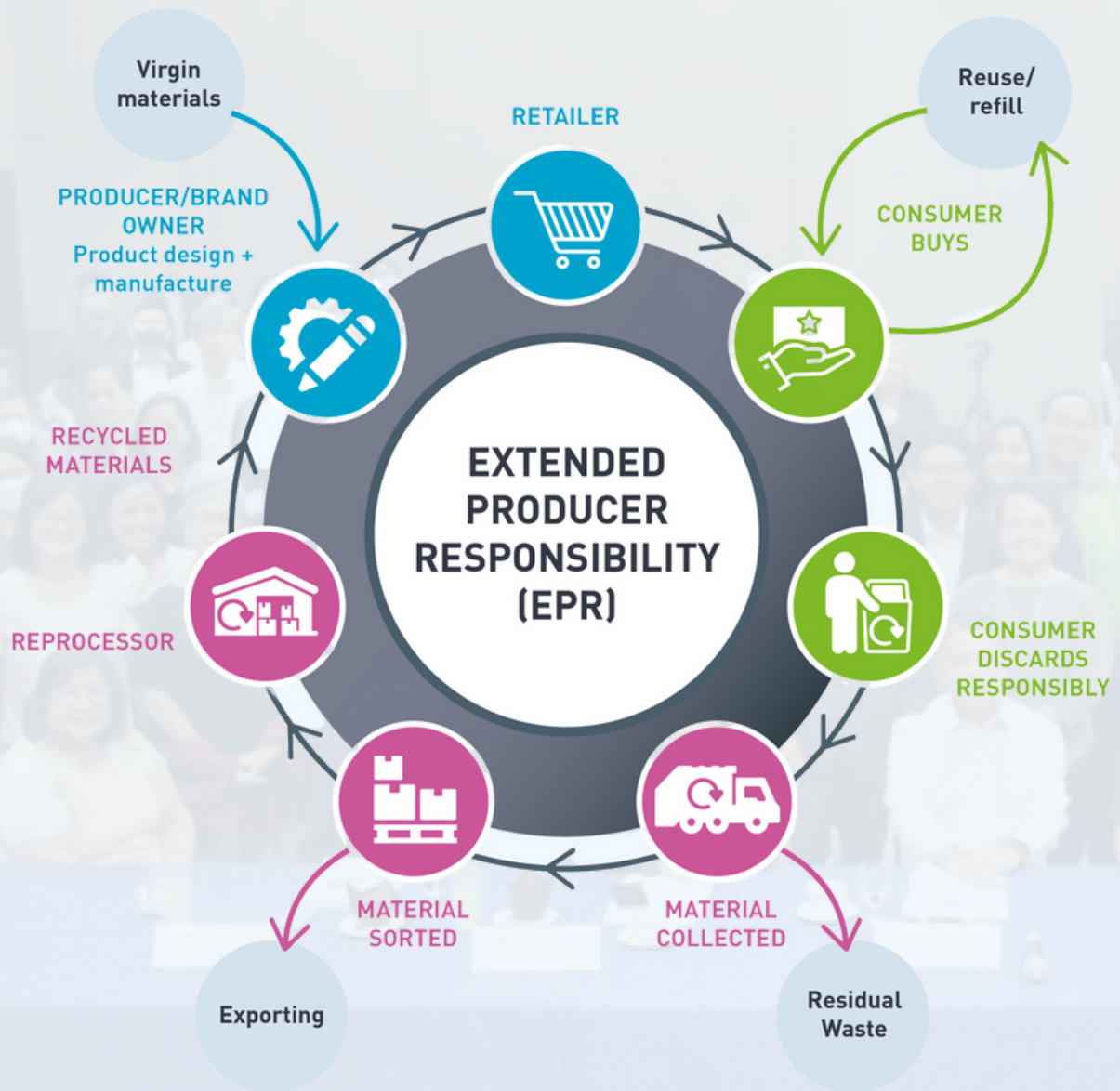

DENR URGES COMPANIES TO REGISTER EPR PROGRAMS FOR PLASTIC PACKAGING WASTE

The Department of Environment and Natural Resources (DENR) is calling on enterprises to register their respective extended producer responsibility (EPR) programs following the issuance of the implementing rules and regulations (IRR) of Republic Act (RA) 11898 or the EPR Act of 2022.

The call is pursuant to a provision in the EPR Act mandating large businesses to set up their EPR programs for plastic packaging within six months after the effectivity of the law.

Specifically, the private sector is expected to submit their registration as an obliged enterprise, as a collective, or as a producer responsibility organization, in compliance with the DENR Administrative Order No. 2023-02 signed by DENR Secretary Antonia Loyzaga, which serves as the EPR's IRR issued on January 24, 2023.

RA 11898, which amended RA 9003 and took effect on August 13, 2022, places responsibility for the entire life cycle of plastic waste on its producers through the development and implementation of its EPR programs that focus on waste reduction, recovery, and diversion.

The primary focus of the visit was to establish the Philippines as exporter of sustainable and high-quality grade cacao in European and Swiss markets. By emphasizing stringent quality assurance and certification standards, the visit sought to understand how cacao is produced by local farmers. This commitment to sustainability extends beyond cacao production, as the delegation actively championed the use of bamboo housing and natural fiber solutions, aiming to revolutionize the construction industry with eco-friendly alternatives.

By exporting sustainable cacao, the visit not only signals support to local farmers' economic growth but also boosts the reputation of the Philippines as a reliable and eco-conscious source of premium cacao. Simultaneously, the advocacy for bamboo housing and natural fiber solutions showcases the nation's commitment to sustainable development and a greener future.

ABB collaborates with Lhyfe and Skyborn on one of Europe's largest renewable hydrogen projects

ABB is collaborating with Lhyfe, a world pioneer in the production of renewable hydrogen, and Skyborn, a global leader in renewable energy, to jointly realize and optimize one of Europe's most ambitious renewable hydrogen projects ever, SoutH2Port.

The new hydrogen production plant, operated by Lhyfe and Skyborn, will be located in the municipality of Söderhamn, Sweden, and connected to Skyborn's 1 GW offshore wind farm in nearby Storgrundet. When fully operational, it is expected to produce about 240 tons of hydrogen per day, with an installed capacity of 600 MW, making it one of the largest suppliers of renewable hydrogen in Europe.

"This collaboration is a key part of our strategy in both the hydrogen and offshore wind markets," said Brandon Spencer, President of ABB Energy Industries. "Creating a seamless supply chain, through partnerships such as these, is essential to accelerate the energy transition. Hydrogen plays a crucial role in helping achieve the world's climate goals when it comes to decarbonizing the industrial and transportation sectors."

As part of the Memorandum of Understanding signed between the companies, ABB will apply critical expertise to optimize the integration of the hydrogen and electricity production across the entire ecosystem including automation, electrical and digital technologies and drive the development of scalable, commercial energy transition projects in and around the region. The aim is to explore opportunities to tie-in Power-to-X conversion technologies turning renewably sourced electricity into carbon-neutral energy carriers, such as hydrogen, and storing the energy for later use.

"We are delighted to have such a global technology leader as ABB, who shares our conviction in the Power-to-X potential of the SoutH2Port project, join our collaboration with Lhyfe. I look forward to taking this project to the next level with the help of ABB and their unrivalled expertise within this field," said Achim Berge Olsen, Chairman of Skyborn Renewables Sweden.

"By combining our expertise and solutions, we can cost-effectively and safely expand the value creation attached to the scale up of renewable hydrogen production," said Taia Kronborg, co-founder and Chief Business Officer at Lhyfe. "Skyborn's track record in offshore wind power, Lhyfe's expertise in renewable hydrogen production coupled with ABB's technological expertise creates new opportunities for enabling Power-to-X solutions linked with renewable hydrogen production at scale."

The new plant will support the decarbonization of the Swedish energy system, either directly with hydrogen supply or by further downstream production of refined fuels such as methanol, sustainable aviation fuel or ammonia – contributing to the government's plans to become the world's first fossil-free welfare country by 2045. SoutH2port will also further contribute to boosting the attractiveness and competitiveness of the region and local society through the creation of new jobs and business opportunities.

ABB is a technology leader in electrification and automation, enabling a more sustainable and resource-efficient future. The company's solutions connect engineering know-how and software to optimize how things are manufactured, moved, powered and operated. Building on more than 130 years of excellence, ABB's ~105,000 employees are committed to driving innovations that accelerate industrial transformation.

PMFTC shifts to electric vehicles

Philip Morris Fortune Tobacco (PMFTC) Inc. has deployed 10 electric vehicles (EVs) for its service fleet to expand its vision to deliver a smoke-free future.

PMFTC was the first tobacco company in the country to deploy EVs for its salesmen.

The electric vehicles will be used in the company's operations in the cities of Marikina and Pasig and in Rizal province.

PMFTC plans to deploy 10 more EV units before the year ends.

"Our journey of transformation is naturally linked to our sustainable fleet initiative. Just as our ambition is to replace cigarettes with better alternatives as quickly as possible, we have a responsibility to have a net positive impact on society by reducing the environmental impact of our products, operations, and value chain. This is our commitment to become a major part of the Philippines' shift towards electro-mobility," PMFTC President Denis Gorkun said.

The EV deployment is in line with Philip Morris International's low-carbon transition plan which commits to achieving carbon neutrality by 2025 and net-zero emissions of its value-chain by 2040.

PMFTC was the first of PMI's affiliates to shift to EVs. The EVs are expected to reduce carbon emissions by 84,954 kilos per year.

"Reducing consumption to cut greenhouse gas emissions, minimizing fossil fuel use and prioritizing nature-based solutions is us doing our part to make sure our employees, customers and stakeholders improve sustainability," Gorkun said.

The company also plans to enhance its telematics technologies to promote eco-driving behaviors and improve safety, efficiency and productivity among its fleet drivers.
