# PSBC now SwissCham Philippines

---

The Philippine-Swiss Business Council more commonly known as PSBC is now the Swiss Chamber of Commerce of the Philippines (SwissCham Philippines).

With support from Switzerland Global Enterprise (S-GE) and the Embassy of Switzerland in the Philippines, PSBC transitions to SwissCham Philippines resulting to a more responsive and innovative chamber initiatives and activities.

This transition paves way to three (3) things: (i) formal registration of a legal entity, (ii) formation of its own secretariat team, and (iii) consolidation and rebranding of all its member benefits and services.

In September 2022, the Securities and Exchange Commission approved the registration of the Chamber as non-stock, non-profit organization with the primary purpose of promoting business cooperation between the Philippines and Switzerland. With this new legal entity, the Chamber is now in a strong position to conduct more activities, projects, and initiatives furthering this purpose. This task is carried with the formation of a functional secretariat currently headed by its Director of Operations, and supported by academic interns.

With its new name, the Chamber embarks on strengthening its member engagement, benefits, and services. A competition was launched soliciting unique proposals from individuals to design the official logo of the Chamber for use in its social media platforms - Facebook and LinkedIn Pages (@swisschamph), and website ([www.swisscham.ph](http://www.swisscham.ph)).

Current members will soon receive an update report during the upcoming Annual General Membership Meeting this year highlighting its transition milestones, and the opportunities it may bring including those prospective and soon-to-be members and partners of SwissCham Philippines.

**Roche Patient Access Program** was established in 2011 to help people who are financially constrained, through a socialized pricing program that considers the individual affordability level of a patient. This includes both medicinal product and care services in the forms of direct discounts, free loading dose, transportation service, membership card program, patient care kit, and diagnostics.

Our **Patient Helpline** is a dedicated hotline which aims to support current concerns and guide cancer patients towards the next steps in their journey by providing access to patient navigation and access to information on critical matters such as the following: cancer disease awareness platforms, nearby hospitals, diagnostic facilities and services; funding and treatment; and support groups.

## Society

We continue to work and help lead a worldwide transformation in women's health beyond innovative diagnostics and medicines. We are partnering with private and public sectors and bringing long-term and sustainable solutions through a patient-centered approach.

**Project BRIDGE (Breast cancer Integrated Disease solutions In a Guideline-driven Ecosystem)** elevates breast cancer care services in Bacolod by upskilling healthcare personnel, connecting breast cancer patients to the multidisciplinary team, and provides a digital platform called GabayKa app, which gives relevant and accurate breast cancer information and link to various breast cancer support programs.

**2030 Mission Leapfrog**, which was piloted in Tacloban City and now expanding to several other cities in the National Capital Region (NCR) and Luzon, aims to accelerate the transformation in healthcare outcomes focusing on the journey of a breast or cervical cancer patient by working closely with healthcare ecosystem partners to provide critical services which includes early detection and timely intervention such as improving primary healthcare and referral system.

**Project ECHO (Extension for Community Health Outcomes)**, with its pilot run in Guagua, Pampanga and Samal, Bataan, in 2021 and 2022, respectively, continues to be instrumental in providing assistance for breast cancer patients during the pandemic by tapping the power of virtual technology towards improving survival and quality of life through early diagnosis. Through an innovative telementoring program, it improves the patient navigation, referral system and funding navigation facilitated by the patient group, local government unit or LGU, and Municipal Social Welfare Department.

# 65th

## Year of Diplomatic Relations between Switzerland and the Philippines

His Excellency Alain Gaschen  
Swiss Ambassador to the Philippines

The New Year generally brings a sense of wonder and optimism, as we look past the trials and tribulations of the previous 52 weeks and look forward to what triumphs and transformations are coming our way in the upcoming year. I was looking forward to a period of consistent normalcy following the improving situation the world was facing towards the end of 2021.

As I enter what would be my third year in the Philippines, I look at what the Philippine-Swiss relationship has accomplished. The Free Trade Agreement (FTA) between the European Free Trade Association (EFTA), of which Switzerland is a member-state, and the Philippines is in full swing. Studies by the Swiss Import Promotion Programme (SIPPO) were also done to understand the potential of Filipino products in the European market. In the field of transitional justice and reconciliation, Switzerland continues to support the peace parties and to follow closely the developments in the recently formed Bangsamoro.

The Swiss presence was also active in the pandemic as mentioned previously, and in other humanitarian aid such as the support provided in recent typhoons like Odette.

Indeed, I can only describe the relationship between our two countries as consistently moving forward and innovating. This ever improving and strengthening of our ties is not new and has been the cornerstone since 1957. Of course, the Philippines and Switzerland can trace its engagement with one another even to the 1800s. This was when Swiss merchants began to set up shop in the Philippines, with DKSH, Zuellig and Nestlé being among the oldest Swiss companies getting settled in the country.



For us, 2022 is an important and historic milestone as it marks the 65th anniversary of formal Swiss-Philippine diplomatic relations. A lot has happened between our two countries since then, but I can only imagine what new opportunities are on the horizon for our relationship. This is why for the 65th Anniversary of Diplomatic Relations, we aim to grasp these opportunities, as we continue “Building the Future, Together.” This goal is our driving force in all our efforts for the next few months, as we search for more avenues of cooperation and collaboration.

One aspect of Switzerland that we wish to further as we celebrate our 65th anniversary is its position as the world's leaders in innovation. This attention to new developments and innovative solutions to various issues reflects Switzerland's core values and can be applied to how the Swiss face the challenges of today. Switzerland has consistently ranked in the top spot as the world's most innovative country, and this is also evident in how we have committed to sustainability and clean technology.

### Green Compliance

---

On 21 September 2022, SwissCham Philippines and Swiss Ambassador Alain Gaschen jointly hosted the monthly gathering of Swiss and Filipino executives for a breakfast meeting with the Department of Environment and Natural Resources (DENR) Assistant Secretary Joan Lagunda discussing on the key legislative priorities of her agency related to sustainability and innovation.

DENR's priority thrusts and directions, which include adopting climate risk lens in national planning and policies; increasing forest cover; conserving protected areas and biodiversity resources; improving air, water quality, and waste management; ensuring water security and resilience in high-water stressed areas; sustainably and reasonably manage mineral resources; and promoting ethical stewardship.

Some of the priority legislative bills were also highlighted, including forest and boundary delineation; sustainable forest management; mineral processing and value-added; mining fiscal regime; regulation on single-use plastic products; and integrated coastal management act.

## Meet our pioneer interns

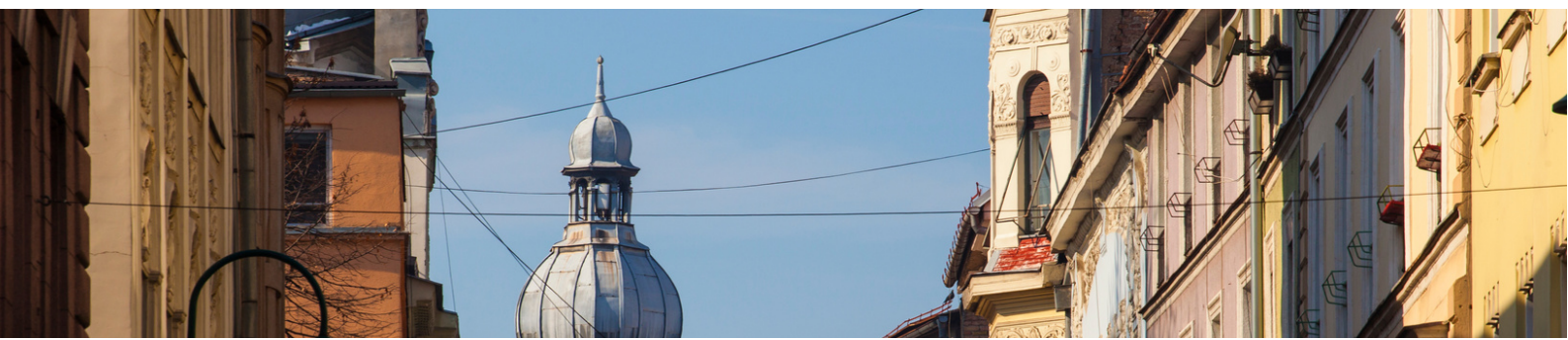

We promote a safer world by ensuring that the products and services that we use and consume daily are safe, secure, and clean.

An interconnected world is what we also envision by becoming more innovative by helping businesses adopt new technologies and enable them to offer these advancements to their consumers quickly and affordably.

The pandemic has greatly affected the most of us resulting to a general economic slowdown but for SGS, it paved the way towards upholding resiliency and being innovative by continuously delivering our world class services despite the many challenges. We have made most of our expertise available remotely, using the latest technology.

One is Remote Auditing. This involved either a partial or complete off-site audit conducted using mobile or desktop applications. We utilized modern technology to cover all aspects of a normal audit in a digital space. This has allowed our clients to maintain their certifications and has given greater flexibility in auditing processes and no disruption to their operations and supply chains.

Another solution is the SGS QiiQ remote inspections, which is basically an app to improve both inspection process and interaction with customers in time of lockdowns..

SGS QiiQ can be installed on any mobile device and operation only requires internet connectivity so the two parties can interact seamlessly and effortlessly.

We have also made knowledge acceleration more accessible in a safe environment through our Virtual Instructor Led Training (VILT). We changed the way we approached learning in the height of pandemic, and technology made us more scalable to keep up with the demand. With VILT, trainings were delivered through a virtual environment with instructor and learner in separate locations. Although this mode of training has been around for decades, we have made it more accessible in SGS during the Covid-19 crisis.

Giving back to the community was never neglected as well. In fact, we have increased our reported community hours by being more strategic in implementing our CSR campaigns with minimal to zero physical contact.

In 2020, we have conducted a food safety training in partnership with a local bread brand and donated several crates of breads to a charity organization. A benefit concert was also held within the SGS community showcasing the talents of some SGS employees while opening a channel to donate to chosen beneficiaries.

Having knowledge-sharing as our strength, we've also conducted a health and safety training to students to create awareness on the COVID-19 situation, environmental issues, and basic risk for grade school to college. Lastly, we've launched online crowdfunding programs encouraging employees to pledge an amount to help local food banks as part of the SGS global CSR campaign - the SGS 15-day challenge.

Today, SGS remains resilient demonstrating a strong operational performance despite the challenging market conditions. Our culture of trust, integrity, innovation, and collaboration that thrives on teamwork and camaraderie has greatly helped each one grow and succeed. Our people have always been the heart of our success and we are beyond grateful for their contributions and commitment.
